In Massachusetts, children aged 3 to 21 may receive special education or related services. State law also requires school districts to create a Parent Advisory Council (PAC) that meets regularly to advise the School Committee on matters that pertain to the education and safety of children with special needs.

[603 CMR 28.07(4)]

The Whitman-Hanson SEPAC meets regularly. District and school administrators and School Committee members attend SEPAC meetings.
